## **Satisfactory Academic Progress Policy**

### Satisfactory Academic Progress Policy:

Students are evaluated at the end of every Spring semester with the exclusion of MTF evaluated at the end of every semester.

# Three criteria to remain <u>eligible</u> for future financial aid:

#### 1) Cumulative GPA –

- 1.8 or better for **freshmen** (after first year, 2.0 or better is the requirement)
- 2.0 or better for **transfer** students
- 2) **Completion Rate** successfully complete 67% of ALL attempted credit hours

### Hours counted as attempted include:

- All credit hours for which the student enrolls at Ohio State and receives any of the following grades or marks: A, B, C, D (including plus and minus), E, EM, EN, K, KD, KM, NP, PA, U, UEN, NEN, S, P, Blank and/or NG
- Hours forgiven with passing grades under the "Grade Forgiveness" or "Fresh Start" rules (#)
- A mark or marks of W (denoting a class or classes dropped or total withdrawal from the university)
- A mark or marks of I, IX (denoting a class or classes that have incomplete coursework)

#### Hours not counted as attempted include:

Courses designated as audit (no credit or grade assigned)

# Hours counted as successfully completed include:

- All credit hours for which there is a passing letter grade or mark as reflected in the Policy Section of the University Registrar's website including A, B, C, D (including plus and minus), S and PA
- All marks of EM (credit by exam) and hours accepted for transfer from another institution, K, KD, and KM

# Hours not counted as successfully completed (deficiencies) include:

- All credit hours for which there is no grade/notation indicating that the course work has been successfully completed including marks of E, EN, NEN, I, IX, NP, U, UEN, W and P
- 3) **Maximum Time Frame (MTF)** for completion of degree requirement (150% course work towards degree)

### Hours counted as attempted include:

 All credit hours for which the student enrolls at Ohio State and receives any of the following grades or marks: A, B, C, D (including plus and minus), E, EM, EN, I, IX, K, KD, NP, PA, U, UEN, NEN, S, P, Blank and/or NG
